ABORIGINAL LANDS AND NATURAL RESOURCES FORUM

The Federal Court of Canada has recently held that s. 91(24) of the *BNA Act* applies to Métis and to First Nations people who do not have *Indian Act* status ("non-status Indians") thus bringing these groups under federal jurisdiction.
